Parent Payments Policy



FREE INSTRUCTION

- Schools provide students with free instruction and ensure students have free access to all items, activities and services that are used by the school to fulfil the standard curriculum requirements in Victorian Curriculum F-10, VCE and VCAL.
- Schools may invite parents to make a financial contribution to support the school.



PARENT PAYMENT REQUESTS

Schools can request contributions from parents under three categories:

Curriculum Contributions

Voluntary financial contributions for curriculum items and activities which the school deems necessary for students to learn the Curriculum.

Other Contributions

Voluntary financial contributions for non-curriculum items and activities that relate to the school's functions and objectives.

Extra-Curricular Items and Activities

Items and activities that enhance or broaden the schooling experience of students and are above and beyond what the school provides for free to deliver the Curriculum. These are provided on a user-pays basis.

- Schools may also invite parents to supply or purchase educational items to use and own (e.g. textbooks, stationery, digital devices).



FINANCIAL HELP FOR FAMILIES

- Schools put in place financial hardship arrangements to support families who cannot pay for items or activities so that their child doesn't miss out.
- Schools have a nominated parent payment contact person(s) that parents can have a confidential discussion with regarding financial hardship arrangements.



SCHOOL PROCESSES

- Schools must obtain school council approval for their parent payment arrangements and publish all requests and communications for each year level on their school website for transparency.

Curriculum Contributions

Items and activities that students use, or participate in, to access the Curriculum, including:

- Everyday items that your child will use in the classroom to learn the essential curriculum such as stationery, art supplies, science experiment equipment, cooking ingredients, technology materials.

Other Contributions

Non-Curriculum items and activities to support the daily operation and objectives of Longford Primary School.

Extra-Curricular Items and Activities

Longford Primary School offers activities through the year that enhance or broaden the schooling experience of students and are above and beyond what the school provides in order to deliver the Curriculum. These activities are designed to broaden the school experience for your child and involve a minimal charge for your child to participate. These are provided on a user-pays basis.

Curriculum Contributions	Amount
<p align="center">Student Stationary</p> <p>There is a custom stationary pack for each grade level as determined by the classroom teacher to ensure students have the correct resources for learning: <i>Included are pencils, markers, exercise books, display folders, glue, post-it notes, whiteboard markers, highlighters and all of the stationary required for the student throughout the year.</i></p>	\$70.00
<p align="center">Bulk Stationary Supplies</p> <p>Each classroom requires items such as cover paper, coloured paper, paper squares, tape, glue, staples, blu tack, project construction items and laminate. These items are purchased in bulk for student use, as it is not practicable to purchase them singularly.</p>	\$10.00
<p align="center">Specialist Subjects</p> <p>All students require consumable items for Art, PE, Music, Science, Indonesian and classroom cooking activities. <i>Included are paint, clay, glue, tape, construction items, workbooks, cooking ingredients and bulk items that are not practicable to purchase in small quantities such as feathers, eyes, fabric and wool.</i></p>	\$30.00
<p align="center">Swimming Program</p> <p>The swimming program in 2024 will run for eight weeks during term's two and three with all classes participating one term each. The cost of swimming instruction is allocated from the school budget, parents are charged only for travel to and from the pool and entry into the pool facility.</p>	\$50.00
